## **DELL GROVE MONTHLY MEETING**

## September 6, 2011

The Dell Grove Town Board of Supervisors met Sept. 6, 2011, 7:35 p.m, at the Dell Grove Lutheran Church. Present were Supervisors Dan O'Flanagan, Randy Davis, Nick Harris, Treas. Frank Grundmeier, and Clerk Janet Foss. Also present were Roger Trapp, Steve Schiller, and John Harris.

The Pledge of Allegiance was recited.

The previous monthly minutes were read. Randy made a motion, seconded by Nick, that the corrected minutes be approved. Carried.

The Treas. Report was read with an ending balance of apx. \$53,480.00 in checking. The statement has not been received yet because of the bank merger. Nick made a motion, seconded by Randy, to approve the report. Carried.

Nick made a motion, seconded by Randy, to possibly spray the following roads this month: Sjodahl, Olson, Grundmeier, Davis, Wahlberg, Wood Pecker Ridge, and North Grindstone Rd from Trapp Rd, then east. Carried. Central Applicators from Foley will be doing the spraying.

Discussed renting a brush cutter for 45 hours to cut the brush on the west side of Swatzky Rd, Skunk Lake Rd east, west Groningen Loop, Nelson Rd, No. Grindstone Rd curves. Nick made a motion, seconded by Randy, to rent a 50" mower and tractor from St. Joseph, Mn, for \$2300 plus \$760 for shipping, for 45 hours of use. Carried.

We have apx. 3500 yards of gravel left. Discussed doing Woodpecker Lane, Yellow Birch, Hammersma, part of Groningen Loop, Miller spot graveling, Grundmeier from Co. 26 to Yellow Birch, south end of Trapp Lane, and Davis Lane. We will have to crush next year.

Dan will file the Lind fire call from July 2010 with the county this week to be put against the property taxes.

Dan will be notified on a meeting for a culvert by the river exit. We will get a permit for replacing the overflow culvert north of the 2 big culverts.

Bldg permits were received from Marv Nelson 19/20, Harry Chapple 31/21, Lola Mills 31/21, and a Cond. Use permit from East Central for Robert Danson 20/21.

A Comprehensive Land Use Plan was received from the town of Finlayson.

Graveled Southfork Rd. 192 yd, Olson Rd 96 yd, and Watrin Rd 324 yd.

Randy made a motion, seconded by Nick, to pay the bills. Carried. Nick made a motion, seconded by Randy, to adjourn. Carried. Adjourned 8:45 p.m.
